To all Commanders/Transportation Officers.

As per CAPR regulation 77-1, para 2-2k, "First aid kits carried aboard CAP ground vehicles, will be inspected regularly to ensure that they are in good condition, that they contain the proper items and to replace components that have been consumed or have expired. A first aid kit component list will be periodically reviewed to ensure that the kit meets the needs outlined in the applicable code. If first aid kits are carried aboard CAP ground vehicles, either **electively** or by law (not required in Connecticut), they will be provided by the unit and the inspection schedule shall be published in a wing supplement to this regulation".

As stated above, the Wing Supplement will be amended to require inspection of vehicle First Aid kits, at each scheduled servicing or six months, whatever occurs first. Additional all vehicle First Aid kits must have a component list and components will be inspected against this list as part of this inspection. All expired items will be disposed of and replaced as necessary. Units will be required to respond to CTLGT upon completion of the required servicing that the First Aid inspection was completed, along with recording on the attached verification sheet. This sheet will be maintained in the vehicle log book.

This inspection will commence effective with the first servicing in calendar year 2015.

This will be included in the next revision of the Connecticut Wing supplement to CARPR 77-1.
